Introduction

- The Rockaway Beach Endangered Species Nesting Area (RBESNA) was established in 1996 as a response to the discovery of federal and state-listed piping plovers and other protected shorebirds nesting on Rockaway Beach, Queens
- Since 2017, the piping plover monitoring program has been managed by NYC Parks' Wildlife Unit

Protection Guidelines

Symbolic fencing is installed to prevent accidental destruction of nests and repeated flushing of incubating adults, and to provide an area where chicks can seek shelter when large numbers of people are on the beach

- Fence off main breeding area(s) with a minimum buffer of 50 meters for piping plovers
- Fence off any individual nests with a minimum buffer of 50 meters
- Maintain fencing until all piping plover chicks have fledged or perished and no further nesting is observed







2022 Results

Piping Plovers

- 21 pairs
- 90 eggs laid
- 46 chicks hatched
- 5 chicks fledged
- 0.24 productivity rate (chicks fledged/pairs)
- 51% of eggs hatched (chicks hatched/eggs)
- 10% of chicks fledged (chicks fledged/chicks)
- 90% mortality (chicks lost/chicks hatched)







2022 Results

American Oystercatchers

- 36 pairs
- 144 eggs laid
- 57 chicks hatched
- 36 chicks fledged
- 1.00 productivity rate (chicks fledged/pairs)
- 40% of eggs hatched (chick hatched/eggs)
- 63% of chicks fledged (chicks fledged/chicks)
- 37% mortality (chicks lost/chicks hatched)






Human Disturbance 5.15.22

Damages

- 19 missing American oystercatcher nests
- 1 missing piping plover nest
- 1 dead piping plover adult
- 2 killdeer nests

Damages

Human Disturbance 6.11.22

Damages

- 1 piping plover nest destroyed
- 1 American oystercatcher nest destroyed





Site changes made after disturbances

- Orange construction fence
- Field cameras set up in back of site
- Removed nest markers
- Locks placed on all boardwalk entrances around site
- Back of site snow fencing repaired or replaced
